## **Qualification of Members** (Article 3)

- (a) No person under the age of eighteen (18) years shall be admitted to membership of the Club.
- (f) The qualification of Ordinary Members shall be that they are persons who at the date of election to membership are:-
  - (i) Players of the game of rugby league football, or
  - (ii) Persons who have been players of rugby league football, or
  - (iii) Persons who are the holders of official positions in any organisation or club controlling the playing or rugby league football, or
  - (iv) Persons who have previously held such positions as are referred to in the previous paragraph, or
  - (v) Persons who satisfy the Directors that by reason of consistent attendance at rugby league matches or personal effort in relation to the organisation, coaching, managing or otherwise carrying out work or duties in relation to the playing of rugby league (whether by teams of the Club or not) they should be regarded as giving substantial support to rugby league.
- (g) Associate Members shall be persons who establish to the Board that they are interested in or are supporters of the game of rugby league football.
- (h) The Board may transfer persons from Associate Membership to Ordinary Membership upon being satisfied that such persons have the qualifications required of an Ordinary Member.
- (i) Associate Members shall not be admitted to the Club unless more than 60% of the Members of the Club at the time of their admission, including Associate Members being admitted, are Ordinary Members.
